84.14 Rocky to himself: "Champignons. I can't believe it. Is this reality or a film?"

84.15 Eva, the mother of Claudia and Rocky are sitting at the table, when Ado arrives through the kitchendoor and says to Rocky: "Here Rocky, eat this. Zero calories!!!"

84.16 Rocky to himself: "Oh God, help me, please. Does he or she wants to kill me? What can I do now and not loosing neither my face nor my life?"

84.17 Rocky takes the champignons and reaches them to Eva and says politely: "Ladies first!!!"

84.18 Eva looking strangely down to her plate at the table: "No, thank you, I have no appetite today!"

84.19 Rocky passes the champignons to Claudia: "My First Lady..."

84.20 Claudia: "For me neither, thank you..."

84.21 Rocky thinks to himself: "If this is an attack onto my life, the girls saved me. Both don't want to eat it. This means, both are knowing that something is wrong with the meal, but who wants to save his own life and who wants to warn myself?"

84.25 After the meal of some salads and fruits, Rocky leaves the house to get some fresh air into his lungs... He shakes his head and says: "Who tried to murder me? Who? Who? Who?"
